This Notice has not been reviewed by the Central Bank of Ireland (the "Central Bank") and it is possible that changes thereto may be necessary to meet the requirements of the Central Bank. The directors of MGIM (the "Directors") are of the opinion that there is nothing contained in this Notice nor in the proposals detailed herein that conflicts with the guidance issued by and regulations of the Central Bank.

The Directors have taken all reasonable care to ensure that, as at the date of this Notice, the information contained in this Notice is in accordance with the facts and does not omit anything likely to affect the import of such information. The Directors accept responsibility for the information contained in this Notice. Unless otherwise indicated, all capitalised terms in this Notice shall have the same meaning as described in the prospectus for the Funds and a Sub-Fund's Supplement, as applicable.

Dear Investor

We are writing to notify you of intended changes to the names of the Sub-Funds, which are planned to take effect on or about the Effective Date (see below).

The European Securities and Markets Authority ("**ESMA**") recently issued guidelines which set out precise criteria for funds which use sustainability-related terms in its name (the "**Guidelines**"). These requirements include investing at least 50% of its portfolio in sustainable investments and specific environmental and social exclusionary screens reflecting those applicable to Paris Aligned Benchmarks. The Guidelines will apply from 21 May 2025.

Having considered the Guidelines and noting the impact for the portfolio to increase and address the higher thresholds for levels of sustainable investments, the Sub-Investment Manager believes it is more appropriate at this time to change the name of the Sub-Funds to remove reference to "sustainable".

The current sustainability-related characteristics and attributes promoted by the Sub-Funds are not changing. However, it is considered necessary and appropriate to revise the name of the Sub-Funds. Accordingly, it is proposed to rename each Sub-Fund by removing "Sustainable" from the current name as outlined in the table below.
