Dear Shareholders,

We hereby would like to provide you with some information related to your investment in Danske Invest SICAV (the “SICAV”) in relation with the share classes of the below funds:

The multi-currency setup, where the investors may subscribe and redeem in currencies other than the share class currency, is expected to be terminated in the future. To be able to subscribe and redeem in NOK or SEK, you will have to be invested in a NOK or SEK-denominated share class, as displayed below under the section “share class name (new)” The termination date will be communicated to you by a separate notice.

To anticipate this change, as of 26<sup>th</sup> June 2023 the management company of Danske Invest SICAV will not accept subscriptions in currencies other than the share class currency.

The new share-classes in NOK and SEK as demonstrated below will be already available for subscription as of 26 June 2023. As of this date you may switch to these new NOK and SEK share - classes within the same funds free of charge.

Please note that the share class Europe Small Cap Class A-SEK with the ISIN LU1916064857 is already available for subscriptions.
