

Leisure-home insurance

Valid from January 1, 2016

Leisure-home insurance includes property-damage, liability and legal-expenses. This document provides general information. The complete terms and conditions are available from our website. You can also contact us by telephone and we will send the terms to you.

Where is the insurance valid?

The leisure-home insurance policy is valid at the insured location.

Who is covered by the insurance?

Leisure-home insurance covers you and the members of your family.

Property-damage insurance – house and possessions

Property-damage insurance covers your holiday cottage, your land and your personal possessions. The term “personal possessions” is defined as your personal belongings, for example, furniture, items of clothing, sports equipment, money and valuable documents.

The leisure-home insurance does not cover everything

The leisure-home insurance does not apply to, for example, cars, motorcycles, mopeds, larger boats, campers or the related equipment.

What does the insurance cover?

The property-damage cover under the insurance pays compensation in the event of, for example

- theft and damage
- fire, explosion and soot damage
- water, oil and other leakage damage
- storm, hail and lightning damage
- damage due to flooding and natural causes
- damage to fixtures and fittings, and household equipment
- foodstuffs destroyed due to breakdown of refrigerator or freezer
- damage to glass panes
- damage caused by wild animals in the home
- sanitation against vermin in the home
- additional costs associated with damage, for example, replacement housing in the event of a fire

What will the amount of compensation be?

Compensation for the possessions in your holiday cottage is paid at the highest insurance amount. You determine this amount yourself when you take out the insurance, but remember that the amount must correspond to the value of your possessions. If the amount is too low, you risk not receiving full compensation for a claim.

One of the factors that determine the amount of compensation is what has been damaged or stolen. Age and wear also affect your compensation. We will decide the way in which you are to receive compensation, for example, whether an item is to be repaired.

Your house is insured at full value

The insurance policy normally applies at full value. Full value insurance is taken out for buildings that you intend to reconstruct or repair if they were to be damaged. You are reimbursed for the costs of restoring the buildings and there is no limit to the amount that can be received. We make an age deduction from the compensation. This “age deduction” is the portion of costs that you are liable to pay yourself, together with the deductible.

What do we not pay for?

- Theft committed by or damage caused by someone who is authorised to be in or has been given the keys to your holiday cottage.
- Surface and sealing layers in leaky walls and floors.
- Water damage from outflow from drainage systems or drainpipes.
- Damage to land from torrential rain or flooding.
- Settlement damage.
- Lighting, drainage systems, roofing, swimming pools, wells, tiled stoves, etc. that are faulty or break down.
- Damage caused by rats, mice or most types of insects.

Duty of due care

Take good care of your possessions

You must have shown due care for us to be able to fully compensate you in the event of theft or other damage to your possessions. If you did not follow the due care requirements stated in the insurance conditions, the amount of compensation may be reduced. The reduction will depend on whether your lack of due care affected your claim and the scope of the loss incurred.

Here are some of the most important requirements:

- All doors must be shut and locked when no one is at home. Windows must be shut and secured. Keys must be stored securely.
- Bicycles must be locked using an approved lock.
- Do not leave fire and candles unattended and make sure that the ashes are properly extinguished before you throw it.
- Let the temperature in your house be at least 15 ° C when you are away. Pour antifreeze in all water traps, floor drains and into the toilet and provide regular maintenance of your house.
- If the home is not heated, turn off the water and drain the water system.

Liability insurance

If you cause injury to another person or property, you may be liable to pay damages. The insurance provides cover for you if someone claims damages from you as owner of the leisure-home.

Advance and after-sale information

The insurance does not pay compensation for claims for damages, for example, that are related to your work or that pertain to you as the owner or driver of a boat or motor-driven vehicle.

We can help you with the following:

- We will investigate whether you are liable to pay damages.
- We will negotiate with the party making the damages claim.
- We will represent you if the case goes to court, and in such a case we will also pay the litigation costs.
- We will pay the damages that you are liable to pay.

The maximum amount of compensation is SEK 5,000,000.

Legal-expenses insurance

Legal-expenses insurance provides financial cover if you, as owner of the holiday cottage, are involved in a legal dispute that can be tried by a district court, for example.

Certain types of disputes are exempt from this legal-expenses coverage, such as divorce disputes, disputes involving amounts of less than half a basic amount, disputes connected to your work and crimes.

You are reimbursed for your legal representative and litigation costs. The maximum amount of compensation is SEK 240,000.

Deductible

The deductible is stated on the insurance policy. A higher deductible applies if we have previously agreed this with you.

A higher deductible applies to certain items and claim incidents. Here are some examples:

- Bicycle – 25% of the claim amount, not less than the basic deductible.
- Legal expenses – 20% of expenses, not less than the basic deductible.
- Leakage damage to buildings, a minimum of SEK 3,000.
- Damage caused by freezing – 10% of the claim amount, a minimum of SEK 3,000 and a maximum of SEK 10,000.
- Flooding – 10% of the claim amount, a minimum of SEK 3,000 and a maximum of SEK 10,000.

If your details change

It is important that you inform us if the details that you have provided us with change. Examples of changes to your details include new address, changed value of your possessions or if you renovate your house.

Incorrect details may affect the amount of compensation you receive if anything were to happen.

Insurance premium

The price of your leisure-home insurance – the premium – is determined by several different factors, such as where you live and the size of your house. The insurance amounts that you choose for your personal belongings also affect the premium. Another factor is the deductible. If you opt for a higher deductible, you will pay a lower premium.

The premium for your insurance is stated on your policy or on the offer you have received.

Period of validity

The insurance coverage is valid for one year, unless we have agreed on a different length of time, and applies from the date stated in the policy. Your insurance cover comes into effect on the day after you applied for the policy, unless we agree on another insurance period.

Swedish law applies to this agreement and any disputes between the parties may be settled in a general court. All communication between the parties will take place in Swedish.

Insurance policy

The agreement between us comprises the insurance policy and the complete insurance terms and conditions. What you want to have insured must be included in the insurance policy. Please read through the policy and contact us immediately if something is missing or incorrect so that we can correct it.

Payment of premiums

New insurance coverage must be paid within 14 days from the date on which we sent you the notice of payment.

Consequences of unpaid premiums

If you do not pay the premium in time, we are entitled to terminate your insurance cover. The insurance cover will cease 14 days after we send you written notice of termination. If you pay the premium within these 14 days, the cover will apply as normal.

Renewing the insurance policy

Your insurance is normally renewed if it has not been terminated at the end of the insurance period, unless the agreement states, or other circumstances dictate, that the policy is not to be renewed.

Right to terminate the policy

You are entitled to terminate the insurance policy with immediate effect if you no longer have any insurance requirements or if any other such circumstances arise.

We are entitled to terminate the insurance policy if you or another insured party grossly neglect(s) your(their) obligations or if we have other extraordinary reasons.

Your right of withdrawal

When you purchase a product or service via the Internet or telephone, known as a “distance contract” you are entitled to cancel the purchase within 14 days. Contact us in such a case and we will assist you. If you have already made

payment, your money will be returned with a deduction for the cost of the time that you had the insurance.

More detailed information about your right of withdrawal is stipulated in the Swedish Act on Distance Contracts and Off-Premises Contracts.

Your personal data

The personal information that Länsförsäkringar obtains concerning you is treated in accordance with the provisions of the Swedish Personal Data Act. The information is processed to allow us to administer the insurance policy, fulfil our agreements, provide good service, conduct marketing activities, compile statistics and for the other purposes stated in the insurance terms and conditions. Your personal data is primarily intended to be used in the Länsförsäkringar Alliance, but may also be disclosed to other companies, associations and organisations with which the Länsförsäkringar Alliance works together. You are also entitled to request that your personal data not be used for direct marketing purposes. Telephone calls with you may be recorded for the purpose of documenting the data provided. You are entitled to request information about and correction of the personal data that we hold about you. Complete information about how we manage your personal data is provided in the terms and conditions for your product, which are available from our website lansforsakringar.se or can be ordered directly from us. We are the entity responsible for your personal data.

Registering a claim

To reduce the insurance companies' costs for compensation based on inaccurate information, insurance companies use an industry-wide claims register (known as GSR). This register contains certain information about claims and details about who has claimed compensation and is used solely in connection with claims adjustment. This means that we can find out if you have previously made any claims with another insurance company.

If we do not agree

If you are not satisfied with a decision or the way in which your case was handled, we would naturally be pleased to re-consider your case. First contact the claims adjuster who was responsible for your case or the complaints officer/customer representative.

If you are still dissatisfied, you can contact the Swedish National Board for Consumer Disputes, which handles non-medical disputes, at www.arn.se, +46 8 508 860 00. This service is free of charge.

You can also have the case tried by a court of law. Your legal-representative costs are often reimbursed under the legal-expenses cover included your household insurance. In such a case, you pay only the deductible.
